#### **Mayor's Report**

- The Mayor & Board of Trustees approved the authorization of the Agreement between the Village and the Town of Hempstead for Street Sweeping Services. On motion by Mayor Schreiber, seconded by Trustee Moore and on roll call vote; the Agreement was unanimously approved. See attached.
- Request for proposals for snow contract bids will be published in The Gateway.
- A truck accident on Jericho Turnpike demolished the store front of 249-50 Jericho Turnpike on Saturday, 9/15/18 at approximately 5:30 AM. The Mayor, Building Inspector Rich Belziti and the Fire Department responders were on the scene. There were no injuries. Mayor thanked all for conjoined response.
- The JWCB Village Yard Sale was on Saturday 9/15/18. Senator Elaine Phillips attended. Mayor thanked K. Woodruff and Trustee K. Dorry for overseeing the event.
- Installation of a new carpet in Village Hall Justice Court is scheduled for the first week of October. The office will remain open.
- The Mayor & Board are seeking volunteers to serve on the Architectural Review Committee and Tree Board due to recent vacancies. The Tree Board is scheduled for Tuesday, 9/25/18 at 7PM.
- Deputy Mayor Juliano gave an update on the Road Project. Road core samples were taken on Sept. 6, 2018 on Hudson and Ontario Rds. west of Commonwealth Blvd. to the dead end borders. After evaluation of the borings, plans for reconstruction for Spring 2019 will be determined. He discussed funding of improvements and plans to manage street disruptions to residents.
