Mayor Schreiber opened the Regular Board of Trustees Meeting at 7:32PM. He led all in the Pledge of Allegiance. He then asked for a moment of silence for the Armed Forces and First Responders. Mayor Schreiber asked if there were any recording devices in the room. There were none.

On motion by Trustee Hagan, seconded by Deputy Mayor Juliano, the Minutes of the November 20, 2017 Public Hearing and Regular Board of Trustees Meeting were unanimously approved.

# Mayor's Report

Mayor Schreiber reported the following:

- Holiday greetings & Merry Christmas to all. The homes in the Village look beautiful with the lights this time of year.
- A State & Municipal Grant Application has been submitted by the Grant Coordinator. It is
  hopeful but not guaranteed to obtain funding for \$125,000 for a Capital Improvement for Street
  Reconstruction for Hudson & Ontario Rds. between Commonwealth & Massachusetts Blvds.
  The streets selected are not set in stone and may change if the grant is awarded.
- Leaf Pick-Up was extended to December 15, 2017 and is now ended. Residents are now responsible to bag their own leaves.
- Village roads were sanded and salted on December 9, 14, & 15 due to the snow and ice. It costs between \$1100 \$1200 per sanding/salting.

- Smoke-n-Coffee Realty, Inc. (d/b/a Ultrasonic Carwash & Fat Ernie's) at 249-24 Jericho Turnpike submitted an additional request for modifications to the permitted use application related to the site plan. The additional request will require a Public Hearing. Smoke-n-Coffee Realty, Inc. Attorney, Howard Avrutine, petitioned the Board of Trustees to decide both submissions together. The Mayor motioned to approve the petitioner's request, seconded by Deputy Mayor Juliano and the Board unanimously agreed to schedule the Public Hearing for the additional submission for January 16, 2018. All Stop Work Orders related to 249-24 Jericho Turnpike remain in effect.
- Real Property Taxes Collections The Mayor & Village Clerk Shea have been aggressively
  pursuing collection of delinquent taxes for 2017 and for all tax liens from 2008 2016. See
  attached tax report submitted by Village Clerk Shea.

# **Highway/Public Works Commissioner Report**

Commissioner George Braun reported that the NYSDOT CHIPS reimbursement check for \$33,742.24 for road repairs was received today by the Village. He expects further reimbursement of approximately \$7,000 from NYSDOT NY PAVE & EWR.

#### **Police Commissioner's Report**

Mayor Schreiber reported that the November police report is not yet available due to staffing changes at the Third Precinct. It will be reported at next month's meeting.
